# ORDINANCE ESTABLISHING CRITERIA FOR THE DETERMINATION OF A RESPONSIBLE QUOTER FOR ORLAND FIRE PROTECTION DISTRICT PUBLIC WORKS PROJECTS

WHEREAS, the Illinois Compiled Statutes, including the Illinois Fire Protection District Act, regulate purchases and contracts entered into by the Orland Fire Protection District; and

WHEREAS, such Statutes grant to the District the authority and discretion to determine what constitutes a "responsible quoter" and it is deemed necessary and advisable to establish criteria to better enable the corporate authorities of the District to determine who constitutes a "responsible quoter" for District public works projects such as construction of new facilities and renovation of existing facilities.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Orland Fire Protection District, Cook County, Illinois, as follows:

SECTION 1: In determining which quoter is a "responsible quoter" on District public works projects, the quoter must comply with the following criteria, and submit acceptable evidence of such compliance, in addition to any other requirements as determined from time to time by the District for the specific type of work to be performed:

- (a) All applicable laws and District Codes and Ordinances prerequisite to doing business in Illinois and the District, including required Village and/or County licenses;
  - (b) Evidence of compliance with:
  - (i) Submittal of Federal Employer Tax Identification Number or Social Security Number (for individual); and
  - (ii) Provisions of Section 2000(e) of Chapter 21, Title 42 of the United States Code and Federal Executive Order No. 11246 as amended by Executive Order No. 11375 (known as the Equal Opportunity Employer provisions).
- (c) Certificates of insurance indicating at least the following coverages at minimum limits established by the District: general liability, worker's compensation, completed operations, automobile, hazardous occupation, product liability, and professional liability;
- (d) All provisions of the Illinois Prevailing Wage Act, including wages, medical and hospitalization insurance and retirement for those trades as covered in the Act;
- (e) Participation in apprenticeship and training programs approved and registered with the United States Department of Labor's Bureau of Apprenticeship and Training;

- (f) The applicable provisions of the Illinois Human Rights Act and the rules of the Illinois Human Rights Commission;
  - (g) Adoption of a Sexual Harassment Policy pursuant to Illinois Public Act 87-1257;
  - (h) Furnishing of Performance and Payment Bonds, if required;
- (i) Certificate of no delinquency in the payment of any tax administered by the Illinois Department of Revenue;
- (j) Certificate that the quoter is not barred from quoting or contracting as a result of a violation of either Section 33E-3 or 33E-4 of Ch. 720, Article 5 of the Illinois Compiled Statutes; and
- (k) Evidence that the quoter has not only the financial responsibility but also the ability to respond by the discharge of the contractor's obligations in accordance with what is expected or demanded under the terms of the contract.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
